IV. NEW BUSINESS:

A. COMMUNICATIONS: Purchase of Replacement Camera and Intercom system:

-Dena Popp, 911 Director, solicited quotes to replace the camera and intercom system outside the Communications Office door. The bid best meeting the needs of the department was provided by Nex-Tech. For the quoted price of \$2,331.94, Nex-Tech will install both a security camera and intercom system. It is noted that the security camera will be integrated in the County's current security system.

Dena Popp, 911 Director, said Communications upgraded the phone system last August to NG911. That upgrade caused the intercom system became non-functional as it will not integrate with NG911. In ition, the camera system that allows them to view visitors at the door, was purchased in 1989, and is buty much non-functional. Two bids were received from Nex-Tech and P&S Security. The costs are fairly close, but Nex-Tech offers a better camera system that integrates into what the Courthouse already

has for cameras and will allow every console at Communications, the capability of seeing and talking to the visitor at the door, to maintain security. Maintenance on the system is not included.

John Debes, IT Director, said only one camera has gone down in about three years and said the County is better off not paying for maintenance.

Commissioner Kruckenberg moved to approve the purchase of AXIS A8004-VE Video Door Station camera and Intercom system, to include installation, configuration, and testing from the Nex-Tech. Cost of the equipment, be about \$2,331.94 to be paid from the Equipment Replacement Fund, Equipment Replacement General Line, 072-00-6380.

Commissioner Davis seconded the motion.

B. BOARD APPOINTMENT: Barton County Planning Commission:

-The County has sought applicants for the Barton County Planning Commission. The focus of the Planning Commission is to plan for the proper growth and development of Barton County through the enactment of planning and zoning laws for the protection of the public health, safety and welfare. Although all applicants must reside in Barton County, the majority of members must be from the unincorporated area. Phil Hathcock, Operations Director, will present an application from Wilmer Wegele.

Phil Hathcock, Operations Director, said there has been a vacancy since April 1, 2017 and explained this appointment would complete the board. Hathcock said only 1 application was received.

C. BOARD APPOINTMENT: Central Kansas Library System Board:

-The Central Kansas Library System supports library services in 17 counties in Central Kansas: Barton, Cloud, Ellis, Ellsworth, Jewell, Lincoln, Mitchell, Osborne, Ottawa Pawnee, Phillips, Republic, Rooks, Rush, Russell, Saline, and Smith counties. The Central Kansas Library System Board meets twice a year to conduct the business of the System, to approve the budget, any resolutions, the system plan, and elect members to the Executive Committee. The Executive committee meets monthly to conduct the general business of the System. The County appointee must be a resident of the regional library system taxing district, this is, within Barton County but outside the district of any local legally established public library. Melissa Nech has applied for the four-year, uncompensated term.

Hathcock, Operations Director, said on July 1, 2017, HB 2102 revised KSA 19-206 which transferred authority to appoint a member to the regional library board from the Governor to the County
