- Commissioner Davis: Barb Esfeld is the President of the Appraiser's Association for the State of Kansas next year. A lot of other counties are not in as good of shape as Barton County. Also spoke about Twitter.
- Commissioner Straub: Attended a class called "Non-public water wells and Regulations" and noted there is not a good system to test for contamination. Also attended "Is your County Strategic" – generations and characteristics. Attended "How to Win Friends and Influence People" and said she doesn't personally use Twitter and noted the millennial generation is really techy. Straub said she was voting delegate in Commissioner Schartz's absence. Straub said the following items were major platform issues:

- Commissioner Davis: Attended meeting on your Local Emergency Management. Amy Miller keeps us up to snuff. Should have phone numbers of neighboring counties in the event Amy was not available.
- Barb Esfeld: Register of Deeds rejoined KAC, now just leaves the Treasurers Association. Looking at the listing of all exempt properties to put back on tax roll. Discussed exempting boats altogether. Attended U40 Mentorship Program and noted strategic planning is very important.
- Becky Wornkey: Are there taxes on boat trailers? Esfeld said, yes, boats were taxed at 30%, and are now at 5%.
- Commissioner Schartz: When they take something off taxes, they should put something back on. Local control is so important.
- arb Esfeld: Encouraged people to find out who is on the tax committee and make contacts. They is an annual legislative meeting along with the Clerk's and Sheriff Associations.
- Commissioner Straub: The House and Senate need good, clear leadership. People don't follow ideas, they follow people.

B. REPAIR OF ROOF: Health Department:

-It was determined that repairs were needed to the roof at the Health Department following this year's hail storms. Phil Hathcock, Operations Director, solicited bids for the required work. Two companies submitted bids. The insurance company, in their review, recommended that Washington Roofing & Insulation be selected as they installed the roof.

Donna Zimmerman, County Clerk/Assistant Operations Director, said Amy Miller, Phil Hathcock and Shelly Schneider contacted the insurance company who said they prefer the Washington Roofing quote since they were the contractors who put the roof on initially. The County will owe the \$2,500 deductible.

The following two companies provided quotes:

Washington Roofing \$25,162 R & R Roofing \$17,792

Commissioner Davis moved to approve the \$25,162.00 quote from Washington Roofing and Insulation for roofing repairs to the Health Department. Payment to be made from the Capital Improvement Fund, Building and Fixed Equipment – Health Line – 071-00-6326. When the County receives the settlement from EMC, staff is directed to return the monies to the Capital Improvement Fund.
