B. PROCLAMATION 2017-11: Barton County Preparedness Month, September, 2017:

-Barton County Preparedness Month, September 2017, is a part of National Preparedness Month, an event hosted by the Ready Campaign and the Federal Emergency Management Agency (FEMA). This Proclamation encourages individuals, businesses and communities to plan and prepare for an emergency.

Amy Miller, Emergency Manager, said the two major hurricanes recently are good examples of why we need to be prepared and noted individuals can learn more about being prepared by going to w.ready.gov. Miller detailed the four part readiness plan: 1) plan for yourself, 2) plan for your leghbor, 3) practice and build out these plans and 4) get involved in your community and other organizations. Miller suggested people learn CPR and first aid so they can take care of themselves until help arrives. A person should also learn how to shut off water, gas and electric to your home.

Commissioner Schremmer moved to adopt Proclamation 2017-11, Barton County Preparedness Month, September, 2017.

Commissioner Straub seconded the motion.

C. 2017 TAX SALE: Update:

-The County recently took judgment on the parcels remaining on the 2017 Tax Sale. Owners are able to redeem parcels until Noon, Friday, October 6, 2017. The sale will be held in the Courthouse Conference Room at 10:00 a.m., Tuesday, October 10, 2017. At this time, 46 parcels remain.

Kevin Wondra, County Treasurer, said they started out with 250+ parcels, but are down to 46 at this time. Wondra, said of the 46, three of them only owe the abstract and court filing fees. Wondra said he will start contacting owners about redemption this week and said the Appraiser's Office will take photos this week to post to the County's website. Wondra said the properties are sold "as is" and said potential buyers should arrive early to get signed in and the property must be paid for before they leave. Commissioner Schremmer has volunteered his auctioneering services again this year.

rental fee should be charged. The modified Agreement was submitted to local agents for their approval. Phil Hathcock, Operations Director, will now present the updated Agreement to the Commission.
