B. COMMUNITY ANTI-DRUG COALITIONS OF AMERICA: Mid-Year Training Institute Recap:
-Tyler Morton, Prevention Advocate with Juvenile Services, and Holly Bowyer, The Center for Counseling, Central Kansas Partnership board member and Suicide Prevention taskforce leader, supervised a youth trip to the Community Anti-Drug Coalitions of America Mid-Year Training Institute. Aaron Deason, Jasmine Figueroa, Makinzie Beneke, Grace Vandine, Alvin Bowyer and MaKiah Webber attended the training in Texas last month. The group will provide details.

Tyler Morton, Prevention Advocate with Juvenile Services, provided details about the recent trip to CADCA mid-Year Training Institute. It was held July 16-20 in Grapevine, Texas. Morton thanked the commissioners and County staff for their efforts in the storm cleanup as it weighed on them as they traveled. There were 2,500 attendees from over 20 different countries.

Holly Bowyer, The Center for Counseling, said the Barton County group was selected on day 2 to present about their community to the entire group at the end because they were doing so well. They were complimented.

Jasmine Figueroa, Great Bend High School Junior, said she attended the open sessions with speakers every day. She learned about people genetically predisposed to dementia, schizophrenia, heart disease and other diseases and that marijuana usage can cause early onset. There have been case studies of roung adults developing early onset dementia. She learned about the repercussions of that behavior and at marijuana now was more potent than in the past and should be considered a hard drug. One session she attended was speakers from Washington who work closely with the White House. Someone in the audience asked why the seltzer drinks were so appealing to younger people. That speaker said it was because of the low caloric content. Figueroa was the only youth in that session and was able to speak to him one on one, sharing her perspective. She did not agree that youth worried about calories and asked where he got the data, he had to back his claim. Her favorite session was "Vive 18". They taught how to ask for funding, get youth engaged, hold a conference and have everyone actively participate. General Price, Founder and CEO of CADCA, had a presentation about the eleven different people at a table, for example: the bully, the critic, the ambitious person, the hungry person and how to deal with these people because you will find them wherever you go. Figueroa said a Finance Officer from the United States Army, a former CADCA trainer, said there was no "I" in team but there was an "ME". You have to recognize that within yourself, find your strengths and apply that to the team.

Makinzie Beneke, Great Bend High School Freshman, said she was a part of the Key Essentials group. One thing that stood out to her was Logic Models. They learned how to take problems from their community and explain them in a reasonable sentence with key components. Their topic was about the increase of vaping in schools. They identified risk factors and root causes. Other groups presented problems in their communities such as gun safety and heroin around the schools. The next step would be to take what they learned and implement in the community through social media, radio etc.

MaKiah Webber, Hoisington Middle School 8<sup>th</sup> Grade, said she learned many things on the trip but wanted to bring back tobacco prevention to Barton County. Youth vape a lot, but they are also smoking cigarettes. Both are extremely dangerous, mentally and physically. Tobacco causes many different cancers, heart disease, gangrene and reduced lung function. She learned that most teens are pressured to vape by their peers. July 1, 2023, the State of Kansas passed a law that a person must be 21 years of lige to purchase tobacco products. This will make it a little harder for teens to access tobacco.

Ivin Bowyer, Ellinwood High School Sophomore, spoke about underage drinking and social access by getting older people to purchase alcohol.

Aaron Deason, a recent Great Bend High School graduate, talked about vaping in schools.

Commissioner Esfeld said it was Deason's birthday and led the group in singing Happy Birthday.

Morton said Deason was 18 years old today and aged out of Youth Crew. They were hoping to keep him involved as a Peer Mentor. Morton added that the group was chosen to present at the final presentation and was very proud of the youth.

Commissioner Hutchinson said he was always amazed at how well these young people speak in front of a crowd. Very well spoken.

Commissioner Zimmerman said they were a group to be proud of.

Commissioner Reif said they were the leaders in Barton County.

Commissioner Schlessiger asked if they go into high schools and recruit, do they do presentations. Beneke said she had recruited friends to Youth Crew. When they invite them to attend the fun activities, the kids get intrigued and educated. Figueroa said that Morton and Katelyn Sigler go to the high schools, middle schools and elementary schools and talk about Youth Crew. They have events and the youth come together for a good cause.

Morton said they facilitate the All Stars program through Juvenile Services, prevention services beginning in 6th grade. They go into all elementary schools in USD 428, middle school in Hoisington and in Aolyrood. Morton said Figueroa had already received 3 or 4 awards this year. Barton County had been asked to possibly host a conference next year, they will work on the details.

-Casey Hubbard, Office Manager / Investigator, will provide details. In January, 2023, the Commission adopted Policy 110, DOJ / OVW Funding – Interaction With Minors, into the Employee Handbook. The Office of Justice Programs (OJP) has since suggested certain updates.

Casey Hubbard, Office Manager, presented details and asked for the changes to be adopted to stay in compliance with the grant.
