B. COMANCHE TOWNSHIP: Board Resignation:

-Mary Barrow has resigned as the Comanche Township Clerk effective June 23, 2017. Should the Commission accept the resignation, the remaining Township board members would then be required to submit the name of a replacement. Ms. Zimmerman will provide details.

D. EMPLOYEE RECOGNITION AWARD: Ryan Lichter, 20th Judicial District Juvenile Services Department, Employees of the Quarter:

-The Employee Relations Committee (ERC) recommends outstanding individuals for the "Employees Recognition Award". At this time, the Commission will be asked to recognize Ryan Lichter, Case Manager, at Juvenile Services. He was nominated for the honor by Marissa Woodmansee, Juvenile Services Director. It is noted that Mr. Lichter has adjusted quickly to new practices in the Juvenile Corrections field and has helped co-workers deal with the stresses of learning new policies and procedures in a short period of time. Wendy Birzer, ERC President, will present the award.

E. COUNTY ENGINEER: 2017 Asphalt Overlay Project:

-The County Engineer accepted bids until July 12, 2017, for the 2017 Asphalt Overlay Project. The project includes 4,528 tons of asphalt to overlay NW 40 Avenue from just north of NW 80 Road to the K-4 highway intersection. Venture Corporation provided the only bid of \$390,874.60. It is noted that the County will be eligible for reimbursement of up to \$120,874.60 through the Federal Funds Exchange Program for this project. The reimbursement is to be transferred back into the Road and Bridge fund. Barry McManaman, County Engineer, and Darren Williams, County Works Director, will provide details.

F. NOXIOUS WEED: Disposal of a 2002 GMC Stahly Spray Truck:

-After the purchase of a replacement unit, the Noxious Weed Department is no longer using a 2002 GMC Stahly Spray Truck that is built onto a 1998 model chassis. On March 20, 2017, the Commission authorized selling the vehicle at auction. Kay Thompson, Interim Noxious Weed Director, will ask that the Commission authorize selling the vehicle by sealed bid or public auction.

G. RESOLUTION 2017-12: A Resolution Establishing a Regular Meeting Schedule for the County Commission:

-The County Commissioners meet regularly in open session so that the business of the County can be transacted in the most expeditious and transparent manner.
