### **A. RESOLUTION 2014-01: Resolution Transferring and Carrying Over 2013 Fire District No. One Unexpended Funds to the Special Equipment Fund:**

-Fire District No. One was created to provide fire protection to a large portion of the northeastern section of Barton County. Financing is provided by the City of Clafin and Cheyenne, Independent and Logan Townships. Consideration is for a request to transfer remaining 2013 funds to the Fire District's Special Equipment Fund.

Jessica Wilson, Barton County Financial Officer, recommended a transfer of \$35,000 to Special Equipment. This would leave a little over \$9,000.00 to fund the 2014 budget. Doug Hubbard wants to transfer as much as possible since they are saving for a new fire truck.

Commissioner Schartz moved to adopt Resolution 2014-01, A Resolution Transferring and Carrying Over 2013 Fire District No. One Unexpended Funds to the Special Equipment Fund.

Commissioner Davis seconded the motion.

All voted aye. Motion passed.


