SHERIFF'S OFFICE: Purchase of a Replacement Detention Transport Vehicle:

-A 2010 Dodge Grand Caravan, with over 215,000 miles, is frequently used for out-of-state and long-distance transports. It is becoming undependable. Sheriff Brian Bellendir suggests that it be traded. After accepting bids, he recommends the purchase of a 2017 Grand Caravan SE (RTKH53) from Marmie Motors Inc. If approved, it is suggested that Equipment Replacement funds be used for the purchase.

Sheriff Bellendir said the 2010 Dodge Grand Caravan has over 215,000 miles on it and noted the vehicle is frequently out-of-state and on long-distance transports. Bellendir said they are beginning to see maintenance issues as well as questions of dependability. Typically, the Sheriff's Office does not budget for replacement of jail transport vehicles, therefore, they requesting replacement of this vehicle from the Equipment Replacement Fund.

The Sheriff's Office solicited bids from four dealerships in Hoisington and Great Bend. Dove Chevrolet and Marmie Chrysler were the only two dealerships providing bids. The low bid of \$20,593 was received from Marmie Chrysler. Dove Chevrolet bid \$22,580.

Commissioner Schremmer moved to approve the trade of a 2010 Dodge Grand Caravan for a 2017 Grand Caravan and that is an SE (TRKH53). Marmie Motors Inc has priced the trade at \$20,593.00. The price is to be paid through the Equipment Replacement Fund, the General Use Line, 072-00-6380. Commissioner Straub seconded the motion. All voted aye. Motion passed.

D. EMPLOYEE BENEFITS: Longevity Pay:

-Longevity pay is a supplemental compensation benefit designed for the employee who has established a long term commitment to public service with Barton County. Once a full-time employee has reached five it is of continuous service, that employee will be rewarded longevity in the amount of \$3.00 for each month of service, with half that for part-time employees. Longevity payment, which is contingent on budgetary conditions, may be awarded in November of each year. At this time, Richard Boeckman, County Counselor / Administrator, will ask that the Commission consider the award of longevity pay.

Richard Boeckman, County Counselor/Administrator, said Matt Patzner put together information for study session last week. Boeckman said the total amount for longevity pay is \$53,299.50 and noted the County budgeted \$56,000 for longevity pay for 2016.

Commissioner Schremmer moved to award longevity payment for eligible employees in appreciation of the long-term commitment to public service with Barton County.

Commissioner Schartz seconded the motion.

All voted aye. Motion passed.

PROCLAMATION 2016-10 DOMESTIC VIOLENCE AWARENESS MONTH – OCTOBER, 2016

- WHEREAS, family and relationships are often counted among life's greatest blessings, and tragically, many Kansans' relationships are tamished by violence and fear; and
- WHEREAS, the crime of domestic violence violates an individual's privacy, dignity, security, and humanity, due to the systematic use of physical, emotional, sexual, psychological, economic and coercive control or abuse; and
- **WHEREAS**, the Centers for Disease Control and Prevention reports that 1 in 5 women and 1 in 7 men have been the victim of severe physical violence by an intimate partner, which translates into 12 million people nationally and approximately 557,275 Kansas or 20% of the Kansas population; and
- **WHEREAS**, the U.S. Department of Justice reports that intimate partner homicides comprise 14% percent of all homicides in the United States and women are twice as likely as men to be killed by an intimate partner; and
- **WHEREAS,** the Kansas Bureau of Investigations reports that 16.5% of all homicides in Kansas in 2014 were related to domestic violence; and
- WHEREAS, in Kansas in 2014, one domestic violence murder occurred every 22.8 days; and
- WHEREAS, in Kansas in 2014, one domestic violence incident was reported to law enforcement every 42 minutes, 12 seconds; and
- **WHEREAS**, in 2015, the Family Crisis Center, Inc.'s Domestic and Sexual Violence Center answered 3,349 crisis calls, sheltered 81 women, men and children, and worked with 198 domestic violence survivors; and
- **WHEREAS**, as this violence is inconsistent with the values of our community, it will not be excused or tolerated and we, as a community, must learn about domestic violence and the impact on survivors, families and the community as a whole; and
- WHEREAS, in declaring October as "Domestic Violence Awareness Month", the Barton County Commissioners encourage all citizens to speak out against domestic violence, to provide support for survivors of these crimes, to encourage community leaders to hold perpetrators accountable, and to make domestic violence prevention efforts a priority by hosting events, by creating policies at school and work, and by working with Family Crisis Center, Inc.'s Domestic and Sexual Violence Center.
- NOW, THEREFORE, BE IT PROCLAIMED, by the Board of County Commissioners of Barton County, Kansas, that October 2016 shall be known as "DOMESTIC VIOLENCE AWARENESS MONTH".
