The Kansas Department of Transportation (KDOT) has offered to exchange the County's annual federal fund distribution for state funds at an exchange rate of ninety percent. The County has the option of using the full share of federal funds in the amount of \$177,410.37 on a project designed with all federal requirements and restrictions. If the exchange is accepted, the County would have the freedom to use the money on road and bridge projects without following federal requirements. There is \$159,669.33 available for reimbursement if the exchange offer is accepted.
