Fire District No. 1, created to provide fire protection to a portion of northeastern Barton County, is financed by the City of Claflin and Cheyenne, Independent and Logan Townships. The Board will consider transferring remaining 2024 funds to the Fire District's Special Equipment Fund.

Matt Patzner, County Administrator, presented details and said as discussed in study session last week, the amount decided on was \$29,000.00. This would set us up well in the 2026 budget and still be able to remain revenue neutral.

Commissioner Reif moved to adopt Resolution 2025-01, A Resolution Transferring and Carrying Over 2024 Fire District No. 1 Unexpended Funds to the Special Equipment Fund. Commissioner Hutchinson seconded the motion.

Commissioner Zimerman asked what the balance was of the reserve account. Chris Steiner said around \$64,000.

Steiner said they did get the grant for a pallet of canned water and were waiting to hear back from OneOk nother grant.
