I. OPENING BUSINESS:

III. NEW BUSINESS:

A. PURCHASE OF A 2014 FREIGHTLINER M2 TANKER:

-Doug Hubbard, Fire Chief, has proposed the purchase of a 2014 Freightliner M2 Tanker from Still Auto Inc., d/b/a Missouri Fire Apparatus. The cost of the vehicle, to include a pump, tank and certain equipment, including light bars and sirens, is \$180,000.00. Fire District No. One has monies in the Special Equipment Fund for this purchase.

Chief Hubbard said this purchase has been an ongoing project for the better part of three years with three unsuccessful grants. Hubbard said the new truck will replace the 1969 American Fire Apparatus pumper that is currently in service until delivery of the Missouri Fire Apparatus truck, which is estimated within six months from the signing of the contract. Plans are to sell the 1969 pumper, estimated value is approximately \$5,000, and put the proceeds back into the Fire District No. 1 budget. Hubbard said the new pumper is the same model as the 1969 pumper and said he does not anticipate any additional costs as all fire hose, nozzles, ladders, hand tools, salvage tarps, airpacks, valves and radios are either provided with new truck or are already in stock and will be transferred to the new vehicle. NFPA striping, fire dist. logos and lettering are provided per the sales contract. Hubbard said once the contract is accepted and signed, it will be returned to the vendor with a check for \$18,000 (10%) with the remaining \$162,000 due upon acceptance of the apparatus. Currently there is \$222,857.49 in the Fire District Special Equipment Fund in line 070-50-6205-44.

Commissioner Schremmer moved to purchase the 2014 Freightliner M2 Tanker as detailed in the March 2018, Sales Contract and this would be from Still Auto Inc, DBA Missouri Fire Apparatus. Cost of the \$\frac{1}{2}\$, \$180,000.00, to be paid from the Capital Improvement / Special Equipment Fund, Vehicular
