-Matt Patzner, Barton County Administrator, will present details. This Budget Amendment Hearing has been scheduled to receive comments relative to amending the 2023 Operating Budget for Fire District No.

Despite the efforts of administrative personnel, budget estimates must be adjusted so that funds fall in budgetary laws.

Matt Patzner, County Administrator, said Fire District No. 1 Budget Amendment request was due to unanticipated revenue from various sources unrelated to ad valorum tax. All these funds have sufficient unanticipated revenue and prior year cash carry forward to fund the requested budget amendments. Amending the budget will increase budget authority by \$16,000 to allow for the transfer of unanticipated revenue into reserve funds for future projects if it is deemed practical and necessary.

The \$16,000.00 along with what they had budgeted would help them be able to replace air packs. Hubbard was retiring January 1, 2024, and Kyle Smith would be the new Fire Chief. Hubbard said he would help them if they wanted him to. County Commissioners had been the governing body since the district started in 1974.

Commissioner Hutchinson asked Hubbard what was next for him. Hubbard said he had a lot of ideas and wife had ideas also. Hubbard said he had been on the Fire Department for 49 years.

Commissioner Reif said Claflin had been fortunate to have him.

Commissioner Zimmerman said she worked with Hubbard when she was County Clerk with the accounts payable and it had always been a pleasure.

Commissioner Schlessiger thanked Hubbard for his years of service.
