II. OLD BUSINESS:

A. REPLACEMENT OF SELF-CONTAINED BREATHING APPARATUS:

-Matt Patzner, County Administrator, will present details. In 2024, Fire District No. 1 put out a Request for Proposal for the replacement of self-contained breathing apparatus as used by firefighters. As a part of that process, a bid was received from Casco Industries. Casco then advised Fire District No. 1 that there was an equipment sale that would provide additional equipment and save the agency approximately \$20,000.00. As the deal was time sensitive, the Fire District ordered the equipment. The Governing Body will be asked to approve the purchase at this time. This item was tabled on December 17, 2024.

Matt Patzner, County Administrator, presented details and asked for approval.

Commissioner Zimmerman said they would be ratifying the purchase. Patzner said that was correct. The purchasing policy would require it to come before the commissioners prior to the purchase. With the savings opportunity being time sensitive, they had to act quickly.

Commissioner Zimmerman said she appreciated the savings.

Commissioner Reif said he understood their old SCBA equipment was outdated by three years or more and they had tried for grants without success. He felt it was a wise move. Chris Steiner, Fire District No. 1, said they had a grant in to ONEOK trying to get reimbursement for the purchase. They were supposed to hear in December but were moved into the First Responder Grant and were waiting to hear.

Commissioner Reif moved to approve the purchase of certain self-contained breathing apparatus (SCBA) other equipment as used by Fire District No. 1. Equipment, as purchased from Casco Industries, tests \$110,888.40. That cost is to be paid from the Fire District No. 1 Capital Improvement and Special Equipment Fund, Equipment Line, 070-50-6165.
