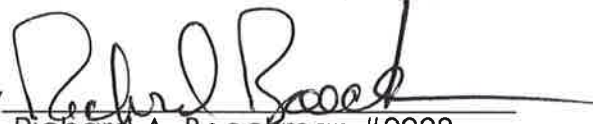
MOTION TO CONFIRM SALE
