Commissioner Schremmer moved to thank the Girl Scout Troop 11126 for their generous donation to the Golden Belt Veterans Memorial.

C. GOLDEN BELT VETERANS MEMORIAL: Project Update:

-Barton County is currently in the process of working on the next two stones for the Golden Belt Veterans Memorial. Stone III has 82 lines available. Side One of Stone IV was purchased by the Hoisington VFW 7428 when it closed. All donated lines have been used. Side Two will be for general use.

Mick Lang, Memorial Parks Advisory Committee Chair, said Committee Members Dan Efeld and John Haberman were also present. Lang said he was sure that all lines on Stone III will be sold and anticipates another stone dedication on Veteran's Day.

NORTHERN NATURAL GAS: Update:

-Greg Alexander, Northern Natural Gas, will provide an update on the natural gas pipelines in Barton County.

Greg Alexander, Northern Natural Gas, said the pipeline signs with the operator name and product carried with contact information is posted at every mile. Alexander explained that if there would be any issues, people should call OCC and 911 and noted the gas is not odorized.

Commissioner Schartz asked how deep the pipelines are buried. Alexander said 24" or less is considered shallow and said, for the most part, they are 3-4 feet deep or more, which is desirable.

E. MEMORIAL PARKS: Mowing Services Proposal:

-The County accepted proposals for mowing at the two County-owned Memorial Parks until 2:00 pm, February 28, 2018. Per the bid form, both Memorial Parks must be mowed and kept trimmed to maintain a grass height no higher than 3", with special consideration for holidays. It is anticipated the mowing will be required from April to October, 2018. There is also an option for renewal after the first year. Monies have been included in the Cemetery Budget for this anticipated expense.

Darren Williams, County Works Director, presented the following bids:

J & J Construction Co., James Lloyd owner	\$10,570 Annually

Williams said J & J Construction Co is the current contractor and has been for the last couple of years and has done a good job.

Commissioner Schartz said she has received positive feedback about the mowing at the cemeteries. Schartz said J & J Construction Co. accidentally broke a monument and offered to repair or replace it. Schartz said when the family chose to have it replaced and it was taken care of.

Commissioner Davis moved to award the 2018 mowing services proposal to J & J Construction Co. for the annual cost of \$10,570.00. Services to be paid from the Cemetery Fund, Maintenance of Buildings, Grounds and Improvements line, 004-92-5515-98.

Commissioner Straub seconded the motion.

F. DISTRICT CORONER: Appointment of Special Deputy Coroner:

-Under the procedures outlined by Kansas Statutes and by Resolution 2006-11, A Resolution Establishing District Coroner Procedures, Dr. Edward Jones requests the appointment of Special Deputy Coroners. Special Deputies, appointed for one-year calendar terms, do not have the necessary credentials to be a deputy coroner, but generally have a medical background. Dr. Jones has requested that Scott Fleming, Hoisington EMS Director, be appointed.

- Denise Rankin (daughters victimized by father): In again for update. Approached the commissioners over a month ago. Had requested a task force to look into the County Attorney's Office. - Carey Hipp, County Counselor: Asked Rankin where everything stood with her letters and where her counsel was with her complaint.
- Rankin: Does not know where things stand. Doug Matthews would not give her straight answers and did not allow her counsel to be present at meetings.
- Hipp: They discussed some type of letter.
- Rankin: The Debolt case made CNN News. Why does it take that to get attention?
- Comm Schartz: We've had problems with other elected officials. Your best bet would be a recall election.
- Comm Davis: Other victims should come together to write a letter to the Attorney General.
- Comm Kruckenberg: Personally commended Rankin for saying something and having the courage to come forward.
- Rankin: Coming to the meetings to put pressure in front of the media. Judicial System needs changed.
- Comm Straub: Unrealistic to think the Barton County Commission can change the judicial system.




