### 5. 2022 Section 312 Tier II Reporting

Amy Miller, Chairperson, told the members that the Kansas Department of Health and Environment had forwarded a reminder letter concerning the web reporting of Tier II reports. The Tier II reporting site opened on January 1, 2023, and will be open until March 1, 2023. The 2022 Tier II online report and applicable fees are due by March 1, 2023. The State is no longer accepting hard copies of Tier II reports and as a result, Miller reported that she changed the Barton County LEPC information on the web page as accepting PDF copies of Tier II reports. Members discussed reporting limits on agricultural chemicals.

The presentation will begin at 6:30 p.m.

### 7. Annual Integrated Preparedness & Planning Workshop

Chairperson Miller reported that the annual Integrated Preparedness & Planning Workshop was held on November 29, 2022. Miller passed out the multi-year calendar that was developed from the discussion and comments during the workshop. Members reviewed the calendar and discussed the listed exercises and training needs.

Judy Goreham reported that there would be a public hearing concerning a large communications tower on the westside of Barton County on February 14, 2023, at 2:00 p.m. If it is approved, construction could begin in June 2023.

Miller announced that the Kansas Division of Emergency Management is holding a Disaster Recovery Regional Tabletop exercise/training on March 28 and March 30, 2023.

Jamie Tomlinson, Russell Rural Water District #3, said that he wanted to assure everyone that the water district served a lot of Barton County residents. There are approximately 500 meters in Barton County. Tomlinson then announced that they had received grant approval for a \$7.2M upgrade to the water district.
