Commissioner Jennifer Schartz said she lost her son to colon cancer 31/2 years ago and said no one wants to lose anyone to something that can be diagnosed and treated. Schartz said she is very sad his uncer was detected too late and stressed if there is anything his life can have added meaning to, it is about getting tested and to have a colonoscopy to have yourself checked for early detection.

Sheriff Brian Bellendir said he was fortunate to be a colon cancer survivor. Bellendir said he was told he had been walking around with the tumor for 2 to 5 years at the time he was diagnosed. Bellendir said it has been five years since he was diagnosed and underwent his colon resection and chemo. Bellendir urged everyone to be screened, especially in the 50-year range. Bellendir said a friend was recently tested and underwent a colon resection. Luckily, it was detected early enough to not require chemo.

D. SOLID WASTE LANDFILL: Proposal for Phase IV Construction Quality Assurance (CQA) Services, Phase IV Cell Construction, Barton County Sanitary Landfill:

-Barton County is accepted proposals for Phase IV Cell Construction (approximately 6.3 acres) at the Barton County Sanitary Landfill until February 28, 2020. This project generally consists of earthwork and composite landfill liner installation for the cell. SCS Engineers (SCS) has submitted a proposal to provide Construction Quality Assurance (CQA) services during the construction period. Proposed work includes documentation and testing for compacted low permeability soil liner, geosynthetic components and leachate collection system as well as survey and data review, CQA report preparation and engineering support / project management. Total estimated cost of services is \$160,000.00.

Phil Hathcock, County Administrator, said KDHE has very extensive requirements for how the cell is constructed. Hathcock said many of those requirements mandate an engineer is on-site.

Commissioner Daily asked when the work would start. Hathcock said they opened construction bids last Friday. He will review the bids and discuss with the Commission at a future date.

ommissioner Davis asked if landfill employees would be able to help. Hathcock said they will help in some manner and noted as they go along, they are always excavating for the next cell. Hathcock said Road & Bridge would help with sand and hauling. Hathcock said they will use sand the County pumps itself, which will also be a cost savings.

Commissioner Schartz said landfills are becoming more difficult to manage and said we are very fortunate to have this landfill and that it speaks to Hathcock's leadership.

Commissioner Kruckenberg said he also wanted to express his thanks to Phil.

Commissioner Schartz moved to accept the Proposal from SCS Engineers for Phase IV Construction Quality Assurance (CQA) Services, Phase IV Cell Construction, Barton County Sanitary Landfill. Estimated cost of the proposal, set at no more than \$160,000.00, is to be paid through the Solid Waste Fund, Contract Construction Line, 140-68-6250.

COLON CANCER AWARENESS MONTH March, 2020

- WHEREAS, the death rate from colorectal cancer has been steadily declining for both men and women for several decades. One reason is because more people are getting screened which helps detect cancers early, when treatment may be more successful; and
- WHEREAS, men and women 45 or older, or those with a family history of colorectal cancer or polyps, should talk to their health care providers about their risk for colorectal cancer and screening, even if they are asymptomatic; and
- WHEREAS, the Affordable Care Act (ACA) requires both private insurers and Medicare to cover the costs of colorectal cancer screening tests, because these tests are recommended by the United States Preventive Services Task Force (USPSTF). Citizens are urged to review their health insurance plan for specific details and to contact the insurer with questions related to colorectal cancer screenings.
- NOW, THEREFORE, BE IT PROCLAIMED by the Board of County Commissioners of Barton County, Kansas, that Barton County joins in the observation of Colon Cancer Awareness Month, March, 2020; and
- FURTHER, that the Commission endorsed the message of the American Cancer Society, and encourages all citizens to learn their family's health history, to be screened regularly for colorectal cancer and to see a health care provider for change in bowel habits, bleeding, unintended weight loss or other symptoms; and
- FURTHER, that the Commission urges all citizens to be mindful of their health by observing safety practices and to bring their health concerns to their own medical care provider or the Barton County Health Department.
