BUDGET AMENDMENT HEARING

9:00 a.m. Until Close

-This Budget Amendment Hearing has been scheduled to receive comments relative to amending the 2021 Operating Budget for the following Barton County Funds – General Fund, Road and Bridge, Special Bridge. Despite the efforts of elected officials and department heads, budget estimates must be adjusted so that funds fall within budgetary laws.

The Budget Amendments will now be presented to the Barton County Commission to receive public comment.

Matt Patzner, Financial Officer, said the budget amendments are due to unanticipated revenue from various sources unrelated to ad-valorem tax. Amending the General Fund budget will increase budget authority by \$1,000,000 to allow for the transfer of unanticipated revenue into reserve funds for future projects. Amending the Road and Bridge budget will increase budget authority by \$315,000 to cover additional purchases of aggregates and other consumable goods that are necessary for operations, as well as future road overlay projects that will be funded by Federal Funds Exchange money and other unanticipated revenue. Amending the Special Bridge budget will increase budget authority by \$190,000 to allow for the transfer of unanticipated revenue into reserve funds for future projects if it is deemed practical and necessary.

Commissioner Krier asked about the term deemed practical and necessary. Patzner said this does not commit you to making the transfer. The amendments would avoid any potential budget violations.

Commissioner Hutchinson asked for the total in reserves for 2021 versus 2022. Patzner said this point last year pre-transfer the County had \$6,884,000 in reserves. After the transfer, the balance was \$9,384,000. Currently, there is just under \$8 million pre-transfer. Hutchinson said we have more in reserves this year than last year which is more now than when he took office.

Commissioner Esfeld said transfers occur in March, correct? Patzner said we have made transfers as early as February, but more recently have been transferring funds in June. Esfeld asked if there is a certain percentage of people who will not pay their taxes. Patzner said generally 3%.

Patzner said at year-end property tax payments are sitting in a holding fund to be disbursed in January to the taxing entities.

Commissioner Krier said we transfer the money in June because of the audit, but I remember making the transfers as early as January/February in the past. Krier asked if that was because of our audit to make sure we spent the money that we get from the federal government the previous year, that we do not have to pay it back.

Patzner said that is a big part of it. If there were anything that needed to be corrected or some sort of major violation and we had to pay that money back, that would obviously affect what we could transfer. Patzner said there is a \$750,000 threshold for a single audit we deal with. Pre-2020 we had gotten close but had not had to comply with the single audit until recent years.

Commissioner Hutchinson said waiting until the very last day of the year gave us a really good overview and exact numbers to work with.

-The Budget Amendment Hearing for the 2021 Operating Budget for Barton County was conducted prior to this Regular Agenda Meeting. Matt Patzner presented the proposed budget amendments during the Hearing. The Commission is now asked to consider amendments that will allow for the current budget to cover the operating expenses and possible transfers to reserves of unanticipated revenue for the General Fund, Road and Bridge and Special Bridge.

Matt Patzner, Finance/HR Director, requested approval of the amendments.

Commissioner Krier moved to approve the 2021 Barton County Budget Amendments.

Commissioner Hutchinson seconded the motion.
