NEIGHBORHOOD REVITALIZATION PROGRAM PUBLIC HEARING 9:00 a.m.

-This Public Hearing is being held to receive comments on the Barton County Neighborhood Revitalization Plan. This plan is intended as a cooperative effort with area taxing districts to promote the revitalization and development of Barton County by stimulating new construction, rehabilitation, conservation, or redevelopment within Barton County.

Wendy Prosser, County Appraiser, said the cities of Great Bend, Ellinwood, Hoisington and Claffin currently have programs that are due to expire December 31, 2021. The cities worked with the county to evelop a county-wide plan that would cover the areas outside of the cities as well. Prosser explained the program is a tax rebate on properties that qualify based on eligibility. Prosser said for residential and agricultural property, a minimum of \$10,000 must be invested and must improve the property's overall assessed value by 5%. Commercial properties require a minimum investment of \$20,000 and must increase the assessed value by 10%.

Patrick Hoffman, County Counselor, said the taxpayer gets a rebate on property taxes and noted potentially all taxing entities could participate. Hoffman said they will attempt to talk to all taxing entities about participating. The county will be the first entity to adopt the plan. The county-wide plan will expire in 10 years.

Prosser said the goal is to encourage new construction, rehabilitate, and redevelop areas. The taxing entities will not be giving away tax dollars that are already there but delaying new taxes from new or improved properties. If the plan is adopted, the plan will need to be approved by the Kansas Attorney General.

Commissioner Schartz asked if the plan will be uniform across the county. Prosser said there are four target areas. Target Area 1 covers all of Barton County except certain areas and is a 10-year rebate. Target Area 2 is the west part of Great Bend with a 5-year rebate. Target Area 3 covers Hoisington with a 10-year plan and Target 4 covers Claflin with an 8-year rebate. The intent if for the plan to be in effect January 1, 2022.

Kendal Francis, Great Bend City Administrator, asked if the plan would go to the state for approval prior to presenting to the other taxing entities. Hoffman said they would get the interlocal agreements in place prior to submitting to the Attorney General. Hoffman estimated it would take 60 days. Prosser said the `ttorney General has been known to make the plan retroactive.

E. PREMIUM PAY FOR COUNTY EMPLOYEES:

-In light of economic uncertainty for and increased risk to Barton County staff due to the COVID-19 pandemic, the Commissioners discussed ways to fairly compensate affected employees. This retroactive premium pay schedule, heavily weighted toward lower income workers, includes non-elected, KPERS covered positions for persons employed with Barton County as of January 1, 2021. The proposed schedule includes a monthly proration factor for employees hired later in the year. If approved, it is anticipated that premium pay would be provided in December 2021.

Matt Patzner, Human Resources / Finance Director said these essential workers in critical infrastructure sectors who regularly perform in person work, interact with others at work or physically handle items handled by others. The proposed retroactive premium pay schedule is designed to be more heavily weighted towards lower income workers who may be more susceptible to the effects of the current economic climate. Patzner said they will calculate a monthly proration factor to workers hired after the first of the year.

Commissioner Krier said we need to retain the employees we have as it is very hard to find labor. We must make sure our employees are benefited and that we keep them.

Commissioner Schartz said not only is it difficult to find employees, but it is also costly to train them. This money has been put in place specifically for employees who have had difficulties due to the pandemic.

ommissioner Daily said we aren't paying our employees well enough. We have made a considerable per forward in increasing pay, but we are still behind. Although this is a one-time payment, hopefully this will help.
