#### 5. LEPC Bylaws

#### 6. Membership of LEPC

Chairman Miller reminded members that the following membership categories would be expiring on December 31, 2022, and would need to be re-appointed: Law Enforcement, Firefighting, Health Personnel, Hospitals, Communications/Media, Facilities, and At-Large County Resident. Miller will mail out membership applications to current members whose terms are expiring. Advertising for new members has been scheduled. It was suggested that a member be sought from a water department or rural water district.

#### 7. Integrated Preparedness & Planning Workshop

Chairman Miller reported hat the annual Integrated Preparedness & Planning Workshop has been scheduled for November 29, 2022, at 10:00 a.m. in the Barton County Courthouse Conference Room. During the IPPW, those in attendance will be discussing Program Priorities, Areas of Improvement, and what training and exercises members would like to focus on for not only calendar year 2023, but 2024 and 2025 as well. Committee members discussed active shooter and public information as areas that need to be considered for both training and exercise.

#### 8. Public Information and Warning

Chairman Miller asked committee members what public information topics they thought would be useful information that should be communicated to the public following a disaster. Message topics that were suggested included information on storm debris pickup, public health notices such as tetanus shots, road closures, water issues such as boil water advisories, and closure or restrictions at medical facilities. Miller said that the topics will be used to guide pre-scripted messages for quick deployment.

#### 9. Training Opportunities

Amy Miller, Barton County Emergency Management, announced that ICS 300 classes had been scheduled for Russell in January 2023 and Larned in April 2023. Miller said she would send out the specific dates to members in an email. Miller also said that the 2023 Wildland Fire Outlook Seminar had been scheduled for Saturday, December 17, 2022, in Hays. As soon she received a registration link, she would forward the information to committee members.
