B. CENTRAL KANSAS COMMUNITY CORRECTIONS: Request for Proposal – CKCC "The Family cace Initiative" Classes:

ny Boxberger, CKCC Director, will provide details. Central Kansas Community Corrections (CKCC) received a Kansas Department of Corrections Behavioral Health grant for curriculums used to assist felony probationers in building skills to live a healthy and productive lifestyle. Selected was the Family Peace Initiative, an alternative to incarceration, designed to improve outcomes for probationers with risk areas in antisocial attitudes, antisocial personality, antisocial companions, or a history of antisocial behaviors, as identified in the KDOC-approved risk assessment tools. CKCC released a Request for Proposal on July 6, and bids were accepted until July 10, 2023. Stepping Stones to Recovery submitted the only bid.

Amy Boxberger, CKCC Director, presented details. Boxberger said they would facilitate the curriculum of six hours a week for fifty weeks ending June 30, 2024. Her office would provide all supplies.

Commissioner Zimmerman asked if there was only one bid received and how many people would be accommodated. Boxberger said there was just one bid and they projected up to 75 people, divided into gender specific groups.

Commissioner Reif asked how many hours a week. Boxberger said one and a half hours each class, twice a week.

Commissioner Reif moved to approve the bid from Stepping Stones to Recovery to provide The Family Peace Initiative classes. Cost of service, not to exceed \$15,000.00, to be paid from the CKCC Fund, Other Contractual Services Line, 095-70-5465.

Under the proposed Resolution, the County has developed procedures specifically for the HVAC Improvement Project at the Barton County Courthouse. Generally, in the event that Project Contractors or Sub-Contractors request a Change Order in an amount less than \$50,000.00, and approval at the next scheduled Commission meeting would likely cause a delay in the project completion, Matt Patzner, County Administrator, may approve said order with the authorization of Commissioner Shawn Hutchinson. If Commissioner Hutchinson is not available, with the authorization of Commissioner Duane Reif. E. STORM DAMAGE UPDATE:

Amy Miller, Emergency Management, said they had a disaster declaration signed and approved by the Commission Chairman on Sunday, July 16th. She would be submitting it to the State of Kansas Division of Emergency Management. Most of the damage was within the city limits of Great Bend, although there was some damage outside the city limits. The National Weather Service did a storm survey yesterday. They determined it was straight line winds with winds up to 85 mph in some areas. Hail ranged from pea sized to baseball sized with some grapefruit sized. Lots of home damages as well as vehicles and glass damage. Miller encouraged everyone to file with their insurance companies. Up to five county vehicles with hail damage and all of the county buildings roofs will be checked for any damage. The City of Great Bend and the new City Administrator opened a cooling center for the public. The Barton County Health Department was offering Tdap shots for anyone needing them.

Commissioner Hutchinson said Karen Winkelman, Health Director, said KDHE was providing the Tdap doses free to the community. They would be set up in the Health Department parking lot and could also go to people in need.

iller said the National Weather Service said it appeared there were two different pushes of the storm. One went through the eastern part of town and out to the south, winds were not as high in that one. The other was on the west side of Great Bend.

Commissioner Hutchinson said he was proud to be a part of this community. Everyone came together and cleaned the area quickly.

Miller said we were very lucky to not have major injuries, there were cuts and scrapes from glass.

Commissioner Zimmerman asked Miller how many residents were still without power. Miller said the last number she saw was 1,500 on Sunday night.

Commissioner Zimmerman was appreciative of the power companies for getting power restored as quickly as they did.

Commissioner Hutchinson said the county assisted with trucks and equipment. He asked Miller to explain why the disaster declaration was important in layman's terms.

Miller said you want to get the disaster declaration in place in the event things are worse than originally perceived. It also allows the power companies to work longer hours. Also allows liability coverage for good Samaritans. It helps speed things up.

Commissioner Reif said anything that could be done to speed things up was helpful.

Dena Popp, Communications Director, thanked Road & Bridge for cleaning around the Communications nter. Mark Kircher from Wheatland for all of his assistance and the City of Great Bend Street Department. Popp said most injuries were minor but they were aware of one that was serious.
