I. OPENING BUSINESS:

A. CENTRAL KANSAS COMMUNITY CORRECTIONS: Board Appointments:

Commissioner Hutchinson moved to appoint Brooke Haulmark to the CKCC Advisory Board for a general open position. Uncompensated term to end March, 2025.

Commissioner Zimmerman seconded the motion.

All voted aye. Motion passed.

B. HUMAN RESOURSES: Recruitment:

-Brenda Kaiser, Human Resource Director, will provide details. Barton County currently has positions open in the County Works, Communications, Attorney, Sheriff and Health Departments. In an effort to recruit candidates and retain employees, the Commission has expanded search efforts and benefits.

Brenda Kaiser, Human Resources Director, said she was here to promote current staff openings within the county. Individuals have retired causing openings in the Road & Bridge Department and Sheriff's ice. There were also openings for RN's at the Health Department and an Assistant County Attorney position. The positions in the county are great for individuals that like a predictable schedule and a more limited travel schedule. Most travel with the current open positions was limited to Barton County with the exception of training. There were equipment operator positions open at both Road & Bridge and Solid Waste Departments. There were also summer positions available at Road & Bridge. 911 also had openings for dispatchers. Full time positions include insurance package with health, vision and dental coverage as well as KPERS. Open positions were listed on the county website, Facebook, Central Kansas Jobs and Indeed.

Commissioner Zimmerman asked Kaiser how many positions were open currently. Kaiser said 14 which included the summer positions.

C. LEGISLATIVE UPDATE:

-Commissioner Barb Esfeld will provide a legislative update. Included will be information on various bills and committee work.

Commissioner Esfeld said there was a lot going on in Topeka and it was hard to track all the bills. Commissioner Esfeld said she and Senator Tyson meet on Fridays with a group of about 10 people trying to find ways to lower property taxes. One of the things they worked on was a bill that would allow County Appraisers to do their job without changing the constitution and legislation. The County Appraiser, by law, sets fair market value. Residential property would still be assessed at 11.5%, commercial at 25% and ag land at 30%. Ag land would not be affected since it was done on a use value and not fair market value. For the other categories, market value would be there but the assessed value would not increase more than 5%. If passed, it would go into effect this year and would require a lot of work from software vendors. Kansas Association of Counties had been working to protect Home Rule. That was the overreach of state remment to make laws that affect local government. One was SB2057 which so far has blocked the outlaw election drop boxes. That should be a decision of the local government. Another one was SB86 which require each commissioner to declare if they had any relatives with a lease or interests in

wid turbines or solar farms. A bill regarding local sales tax had already passed the senate but had not passed the house yet. They were looking at doing the Blue Ribbon Study, a deep dive study into taxes. It would investigate all forms of taxes and ways to help. Commissioner Esfeld said she had asked some constituents who called her about their property valuation to ask themselves if they could sell it for that amount. She encouraged people to call the County Appraiser's office and schedule a meeting.

Commissioner Hutchinson asked if the taxpayers had until the end of the month to appeal. Prosser said until March 31st.
