A. RESOLUTION 2024-15: Barton County Courthouse Heating, Ventilation, Air Conditioning Improvement Project:

-Chairman Barb Esfeld will provide details. After several decades of discussion, the Heating, Ventilation, Air Condition (HVAC) system at the Courthouse has been updated. The Commission directed administrative staff to begin investigating options relative to replacement in 2017. Following a feasibility study and project development phase, the County has worked with Orazem & Scalora Engineering, P.A., DMA Architects, P.A., Kruse Corporation, Brentwood Builders and several sub-contractors for the last year in making improvements. Included therein was moving the Treasurer's Office to the First Floor of the Courthouse to better serve citizens.

Commissioner Esfeld presented details and said when the project got underway, plumbing issues were discovered. They were aware that the corners of the building leaked and were concerned about any structural problems. Commissioner Esfeld said COVID funds helped pay for the project and thanked the previous commissioners for saving money for the courthouse. Those commissioners were very good stewards for the courthouse. Commissioner Esfeld said everything was painted inside and new carpet installed. A big change was moving the Treasurer's Office to the first floor because it was the highest traffic department.

Commissioner Zimmerman seconded the motion.
All voted aye. Motion passed.

Commissioner Esfeld said they were happily surprised to finish on time and on budget. The commissioners recognized County Administrator Matt Patzner and Dereck Hollingshead, IT Director for going above and beyond throughout the project. Having the IT Department saved a lot of money.

Patzner said the reason he could be calm was because of the great team behind him. This would not have been possible without the high caliber staff in the IT Department and employees stepping up. Patzner said he was blessed to be in the position he was and had the support.

Commissioner Esfeld said all of the employees helped and no offices were closed during the transitions.

Commissioner Reif said he appreciated this building and everyone doing the work. He commended the previous commissioners for their foresight.

Commissioner Schlessiger echoed Commissioner Esfeld sentiments and said the county employees were a great team.

Commissioner Hutchinson said the temporary buildings were not perfect but there were very few complaints. He continued that it would have been easy to not do anything and let the building decline but they saw the need. It belonged to the taxpayers of Barton County. The building now had fresh air being pumped in and it had made a huge difference.

Commissioner Zimmerman said everything had already been said but she added that she was proud. Commissioner Zimmerman said she was proud of Barton County, the employees, Patzner and Hollingshead for all their work. She loved the building, having worked in it for a number of years and was glad to be part of the project.

Commissioner Esfeld invited everyone to the ribbon cutting on Friday at 1:30 and said tours would be given until 6:00 P.M.

Commissioner Hutchinson said the first one hundred people would be given drink tickets courtesy of Brentwood Builders.

## B. CITY OF GREAT BEND: Great Bend Airport Airfest Sponsorship:

-Christina Hayes, Community Coordinator, and Martin Miller, Airport Manager, City of Great Bend, will provide details. The Great Bend Airport Airfest will be held at the Great Bend Municipal Airport September 20 – 22, 2024. This sponsor-driven event generally includes rides and tours of historic warbirds, airshow, veteran recognition and displays. At this time, the Commission will consider event sponsorship.

Christina Hayes, Community Coordinator, said she was proposing a partnership with Great Bend Airfest, an event that happens only every three years. Commissioner Hutchinson moved to provide \$20,000.00 in sponsorship funding for the Great Bend Airport Airfest. Sponsorship to be paid through the Finance General Account of the General Fund, Economic Development Line, 001-26-6880.

Commissioner Esfeld asked Commissioner Hutchinson if he wanted to match Great Bend, they are \$25,000.00.
