-Karen Winkelman, Public Health Director, will provide details. The Barton County Health Department has taken innovative measures to reach area citizens, to include expanded hours, digital outreaches, community vaccine initiatives and more. Through the promotion of physical and mental health advancement from birth through senior adulthood, Public Health provides a wide range of services. An overview will be provided at this time.

Karen Winkelman, Public Health Director, told the commissioners Winston Churchill said healthy citizens were the greatest asset that any country can have. Winkelman said with that in mind, that was their why with public health. Winkelman gave an overview of the innovative measures her department used to reach area citizens, including expanded hours, digital outreaches, community vaccine initiatives among

others. Winkelman said with over twenty grants with focused measures, it was important to position her department with community partners as prevention was a huge part of public health. She said other activities included air quality monitoring, emergency preparedness measures, car seat safety, childcare oversight and transportation. Winkelman said the Drug Take Back Day would be held this Saturday outside the courthouse. Winkelman said she appreciated the commissioners acting as the Board of Health and willingly meet with the Health Advisory Board.

Commissioner Zimmerman asked Winkelman how many grants they currently had. Winkelman said they were working with about 20 currently.

B. JUVENILE SERVICES: Stepping Up for Juvenile Justice in Kansas Update:

-Marissa Woodmansee, Juvenile Services Director, will provide an update on the Stepping Up for Juvenile Justice in Kansas program. Governor Laura Kelly, in collaboration with the Kansas Department of Corrections (KDOC), initiated the juvenile justice-focused Stepping Up initiative to address the prevalence of behavioral health needs among youth in Kansas. The program's aim is to reduce the use of detention and increase connections to improve outcomes for youth and families and enhance community safety.

Marissa Woodmansee, Juvenile Services Director, said Governor Laura Kelly, in collaboration with the Kansas Department of Corrections, initiated the juvenile justice focused Stepping Up initiative to address the prevalence of behavioral health needs among youth in Kansas. The program's aim was to reduce the use of detention and increase connections to improve outcomes for youth and families and enhance Community safety. Woodmansee said the model was used with adults and had now expanded into the juvenile world. As part of a pilot program, Woodmansee and her team were asked to answer questions that included such things as Do you have local resources? What are your strengths and weaknesses? What does data support? What funding is available? She also explained that there are "intercepts" at the points of contact – Prevention and Early Intervention (school resource offers, behavioral health and substance abuse resources); Law Enforcement Contact and Initiated Diversion (law enforcement, Juvenile Services); Referrals, Detention and Diversion; Judicial Processing; Detention and Reentry / Aftercare.
