. .ly Ferguson, Rise Up Central Kansas Coordinator, thanked the commissioners for allowing them to come today. Ferguson said Oxford House residents were present today. She said they were often the first step in getting families back together and helping them address children who were drug endangered. Ferguson said they wanted to bring awareness to an often overlooked group, children who were living in homes where substance use was present. These were drug endangered children who were significantly affected by instability, trauma and neglect. Ferguson said the goal was to unite community partners, people with lived experience, healthcare providers, advocates and law enforcement to better identify and support these children. The proclamation served as a formal recognition of their needs and commitment to working together, providing them with safety, stability and hope. Ferguson said it was a gift to be happy, joyous and free.

Ferguson and Oxford House residents read the proclamation.

Commissioner Zimmerman thanked them all for being here and bringing awareness to an important issue.

Commissioner Reif thanked them also.

Commissioner Hutchinson moved to adopt Proclamation 2025-09, Drug Endangered Children Awareness Dav.

B. ECONOMIC DEVELOPMENT: Façade Improvement Grant 2025:

-Matt Patzner, County Administrator, will provide details. Barton County and the participating Cities of ilin, Ellinwood and Hoisington are proud to announce the opening of the Façade Improvement Grant Frogram 2025. This program provides financial assistance to businesses and property owners for façade improvements to defined areas to create a visual impact and increase economic prosperity, accessibility and quality of life in Claflin, Ellinwood, Great Bend and Hoisington, Kansas. Planned are two projects each in the participating Cities of Claflin, Ellinwood and Hoisington (\$20,000.00 cap) and six in Great Bend (\$10,000.00 cap).

Matt Patzner, County Administrator, presented details.

Commissioner Hutchinson said today was the kickoff for FIG 25 and was actually Round 4 of the program. Commissioner Hutchinson said he had now lived more than half of his life in Barton County. He said the program had created the biggest changes he had seen in the downtown of our communities. He said we started with ARPA Funds that were designated to help spark the economy following COVID and he was proud it could continue. As the ARPA Funds dwindled, the way to continue was to split the costs with the cities. He looked forward to seeing the applications and what people wanted to improve.

Commissioner Zimmerman asked Patzner how many projects had been completed. Patzner said around 60-65 projects. Commissioner Zimmerman said that was something to celebrate and it was exciting to have been a part of it.

Commissioner Reif noted that all the work had been done by local contractors, and it was great how they had benefitted from it. He said the program started the year before he became a commissioner and admitted that he was a little hesitant at first. Commissioner Reif thanked Commissioner Hutchinson for motivating the program and added that was exactly what ARPA Funds were intended to be used for.

mmissioner Hutchinson said it could not have continued without the support of the commissioners. He liked the three newer commissioners for jumping in and supporting the program so it could continue.

inmissioner Hutchinson said there had been 63 projects with 10 still incomplete. Some of those were waiting for historical approvals among other things. There have been 43 local contractors utilized so far. What an amazing contribution we have been able to make.

Commissioner Schlessiger said there were very few things they had done that had such an immediate visual impact. In Ellinwood, Sauer's were finishing their project. They had well exceeded the budget and put their own money into it.

Commissioner Zimmerman said you could see pride when you drive through the communities, it looked like a great place to live. It was good for business recruitment as well as other things.

Commissioner Reif said it was not just the funds the county provided but the owner contributed also and helped the local communities.

Commissioner Schlessiger said it was great to see everyone come together when they had the meeting with Ellinwood, Claflin and Hoisington.

Commissioner Hutchinson said the total award was \$1.08 million which turned into \$1.926 million.

## C. RESOLUTION 2025-08: A Resolution Transferring and Carrying Over 2024 Unexpended Funds to the Capital Improvement and Equipment Replacement Funds:

-Mr. Patzner will present details. After accounting of all 2024 transactions, monies are suggested for transfer to the Capital Improvement and Equipment Replacement Funds.

Matt Patzner, County Administrator, said it was the County's practice to transfer unexpended funds from year to the next. After discussions with the commissioners and in light of the uncertainty of the economy, the proposed transfers would better position the County for the future.

To Capital Improvement, Total Transfer - \$464,804.09

General Fund \$300,000.00

Federal Funds Exchange \$164,804.09

To Equipment Replacement, Total Transfer - \$150,000.00 Road & Bridge \$150,000.00

Patzner noted that the \$1.3 million in tax credits was not included as that occurred in 2025 and this was a snapshot of the end of 2024.

Commissioner Zimmerman asked Patzner what that brought the balances to in both reserve funds. Patzner said all in, right around \$8 million with everything.

Commissioner Zimmerman said that was something to celebrate when you think about how hard that vote was to make when the three commissioners had just taken office, deciding to repair the courthouse.

Commissioner Schlessiger said they had all been concerned about where they would come out with the reserves and that vote was difficult.

Commissioner Hutchinson said he was proud to serve with them. They took office and in their second week had to make the decision to repair the building. It was difficult but they got through it.

mmissioner Reif said a lot of hours were spent debating the decision.

Patrick Hoffman, County Counselor, said this was a housekeeping issue to approve annexing a portion of a roadway. Ellinwood was in the process of cleaning up their boundary lines with the new hospital area. This would annex half of the roadway not currently in the city limits, but they would like to add to the city limits. Hoffman said allowing this annexation would have no negative impact on the county and cost zero dollars. He strongly recommended supporting it.

Commissioner Reif said at first it sounds like a large area, but it was actually minimal.

Commissioner Schlessiger said it was basically 30 feet of road.

hoffman said it was common for boundary lines to be in the middle of the road but the City of Ellinwood was requesting to add the entire road.

### Drug Endangered Children Awareness Day
