B. RECOGNITION OF RETIRING EMPLOYEE: Lt. David Paden, Barton County Sheriff's Office:

-Sheriff Brian Bellendir will provide details. Lt. David Paden was hired by the Sheriff's Office on November 2, 1992. Hired as a Detention Officer, Lt. Paden has also served as a patrol officer, K9 officer, detective, detective sergeant and ends his career with the Sheriff's Office as the Lieutenant. The Commission will honor Lt. Paden for his 33 years of exemplary service.

Sheriff Brian Bellendir shared details of his service and said on behalf of the Sheriff's Office, they would like to recognize Lieutenant David Paden who was retiring today. Bellendir said his first conversation with Paden was telling him to get a haircut. Bellendir presented Paden with a plaque honoring his legacy at the Sheriff's Office. He thanked him for his service and dedication to Barton County.

Commissioner Zimmerman read a letter that was written to Paden.

Paden said he was humbled and honored to have served Barton County. He and his wife raised three boys in Barton County. He knew law enforcement would never make him rich money wise, but he was rich with family. Paden thanked the commissioners for the benefits Barton County provided, he was able to retire and support his family.

mmissioner Esfeld thanked Witt for his efforts. She said that Michael Roth had reached out to her while she was in Manhattan to insure her that he also cared about Cheyenne Bottoms.

Kip Spray, Venture Corporation, said they started mixing the cold mix asphalt for Barton County this morning and invited the commissioners to visit the site.

C. COMMISSION REPORT: Kansas County Commissioners Association Meeting:

-Commissioner Barb Esfeld will provide details. The Kansas County Commissioners Association held their annual meeting last week in Manhattan. Information from the meeting will be shared at this time.

Commissioner Esfeld said Wendy Prosser, County Appraiser, and Christina Doyle, Deputy County Appraiser, attended a session about serving the public. Commissioner Esfeld said Monday night she attended the Kansas National Resource Coalition Meeting. They reviewed their accomplishments made on the county's behalf. Jay Hall, Counsel for KAC, and Mike Taylor, lobbyist, went over this year's legislative session. They said it had been the most difficult year as things changed repeatedly. They were reminded that they could face cuts if the federal government cuts at the state level and that should be considered when working on the budget. Commissioner Esfeld said a study would be done this summer about possible legislation to cut property taxes. There were several bills regarding property tax but none of those passed. They were going to look at eliminating sales tax exemptions totally \$8.7 billion. If that were to be successful, that would go towards property taxes.

Commissioner Hutchinson asked if they provided examples of who would no longer be tax exempt.

Commissioner Esfeld said it would include everyone.

nmissioner Esfeld said she found it interesting that SB119 did not pass due to Senator Francis not believing the Treasurer's numbers were correct. She said there would be an audit done this summer in all Treasurer's Offices. Registration fees on electric cars increased from \$100 to \$165, gas taxes went down some but would still increase to help fund the byways. There were several election bills, one was to eliminate the three-day grace period for receiving mail ballots beginning in 2026. Even though fireworks could now be sold year-round by SB199, it would still be up to the cities and counties about times for discharging fireworks. County websites will need to be ADA compliant, not sure what that involved yet. The state will pay for Revenue Neutral Rate notices to be mailed for the next two years and the form changed for 2025. Commissioner Esfeld said there were sessions regarding cyber security and Dereck Hollingshead, IT Director, had Barton County covered. Other things addressed were building prosperity for housing needs, AI tools and KAC was wanting to create a program to shape County Commissioners. The bill that boats and ATV's would be tax exempt passed with the elimination of airplanes. There were sessions on the commissioner's responsibility for public health and mental health, the state food sales tax was now gone as well as the state's 1.5 mills was gone for now.

E. COUNTY ENGINEER: Kansas Department of Transportation Federal Funds Exchange:

-Barry McManaman, County Engineer, will provide details. The Kansas Department of Transportation (KDOT) has offered to exchange the County's annual federal fund distribution for state funds at an exchange rate of ninety percent. The County has the option of using the full share of federal funds in the ount of \$177,410.37 on a project designed with all federal requirements and restrictions. If the hange is accepted, the County would have the freedom to use the money on road and bridge projects without following federal requirements. There is \$159,669.33 available for reimbursement if the exchange offer is accepted.

Barry McManaman, County Engineer, presented details and said were the offer accepted, the county could use the funds at their discretion without having to follow all the federal requirements. McManaman said the county had participated in the exchange since 2013. It had served the county's needs well and asked for approval.

Commissioner Zimmerman said McManaman explained that if we did not do the exchange and had to follow the requirements and restrictions, it would cost more money. McManaman said that was correct. McManaman said the funds could also be shared on different projects such as bridge repairs and overlay budget.

Commissioner Zimmerman said she understood most Kansas counties participated in the exchange program.

Commissioner Hutchinson moved to accept the KDOT federal funds exchange rate of ninety percent making the amount available to Barton County \$159,669.33. Authorize the County Engineer to submit the Request to Exchange Federal Funds to KDOT. Once received, said monies are to be deposited in the Road and Bridge Fund, State Funds Received Line, 002-00-4325.

Commissioner Zimmerman seconded the motion.
