BUDGET HEARING

At 9:00 A.M. Commissioner Zimmerman moved to enter into the Budget Hearing. Commissioner Hutchinson seconded the motion.
All voted aye. Motion passed.

BUDGET HEARING: 2026 Operating Budget:

-Matt Patzner, County Administrator, will provide details. Elected officials, Department Heads and supported agencies were asked to submit budget requests for the 2026 Operating Year. The mission reviewed the requests and, with the assistance of the Administrator, drafted a balanced rating budget. The proposed 2026 Operating Budget is now presented to receive public comment.

Matt Patzner, County Administrator, said it was his privilege to present the proposed 2026 operating budget. This budget was the organizational blueprint to maintain delivery of quality public services at an affordable cost to the taxpayer. The main goals were to remain revenue neutral, meaning to levy the same or less tax dollars, maintain quality public services in a way that was sustainable for years to come, invest in our employees to deliver these quality services and contribute to the expanding tax base, enriching the quality of life of the citizens. Patzner said every budget year was unique and presented its own challenges. They had to find a way to accomplish all these goals with continuing rising costs for commodities, services and quality personnel with fewer ad valorem tax dollars than the previous year. The proposed budget showed a mill levy of 33.921 for the countywide assessed valuation of \$352,016,332 which would generate a total of \$11,941,414 in ad valorem tax. This was \$18,407 less than the amount generated from the 2025 budget. When comparing the mill levy to 2025, the proposed estimated mill levy would be a reduction of 1.898 mills from 35.819 to 33.921. Patzner said this budget came in at .004 mills under the prescribed revenue neutral rate of 33.925 as provided by the County Clerk. Furthermore, when comparing the proposed 2026 budget to the 2021 budget, there could be a 12.397 mill levy reduction and \$284,312.00 reduction in dollars levied if this budget was adopted as presented. The mill levy went down quite a bit in that time span, some of which was due to increased valuation, but the amount of tax dollars collected had gone down \$284,000. Patzner said expenditure authority across all budgeted funds was up 820,305 from 2025 largely due to increases in personnel costs, health liability insurance costs, anticipated Road & Bridge expenditures, increased community development and outside agency support funding, 911 maintenance contracts and various increases to commodity and contractual lines. It was possible to absorb these increases in budget authority in 2026 by beginning the year with a higher cash carry forward position and increased anticipated revenue from sources other than ad valorem tax such as sales tax, departmental revenue and interest. Patzner said we

committed to facilitating lean, efficient county operations, eliminating 11 positions through attrition over the past few years. The proposed raise structure was equivalent to \$0.50 per hour for all county employees. Patzner showed a chart for anticipated revenue for all levied funds. Ad valorem tax made up

less than half of the total revenue required for the county to have a balanced budget. Patzner noted that this was the first time since he had been involved in the budget that this piece had been less than half. He said in 2020 and 2021, it was around 59%-60%, we have reduced it by 10%-11% over the past few years.

Commissioner Hutchinson asked Patzner what you are saying is that less than half of our budget was being funded by property tax dollars. Patzner said that was correct. Patzner said when we go through the process of creating the budget, that really illustrated what we can control, how being lean and stretching every dollar, is a result of that. It was a good goal to work towards each year, keeping the ad valorem tax piece of the pie chart as low as we possibly could.

Patzner continued that as with all budgets, the goal was to maintain quality public services. We will try to keep the ad valorem tax number as small as possible to be good stewards of the taxpayer's money. Cash carry forward, motor vehicle tax, sales and use tax, departmental revenue, fees, transfers, interest and special county highway funds and grant funds make up the rest of the financial resources that we need for a balanced budget. Patzner shared a chart showing the six different categories of general government services, public safety, public works, solid waste, public health, community development and agency support. Of the 25,979,755 in expenditure authority across all funds, 67% is either public safety, public works, solid waste or public health. 31% were general government services and 2% was community development and outside agency support. Dependent upon where a taxpayer lived, only 18%-22% of their property tax dollars supported Barton County government.

Patzner said in summary, the 2026 budget was funded by a mill levy that was 1.898 mills less than the previous year and consistent with a prescribed revenue neutral rate which generates \$11,941,414. This was made possible with careful planning and the foresight to begin 2025 with a sufficient level of cash ry forward to deal with project costs, inflation and ever-increasing contract and commodity prices while making a healthy transfer into reserves for the future. As future budgets present themselves, they would bring with them unique challenges. With adequate cash reserves, zero debt and careful planning, the county can address these in a sustainable way with the leadership of the county commissioners, the diligence and care of department heads and high quality of employees. Barton County remained fiscally sound and was in a position to maintain a sustainable mill levy for years to come while still contributing to the expansion of the tax base and providing quality public services.

Patzner thanked the commissioners for their hard work on the budget as well as the elected officials, department heads and supported agency heads. He wanted to recognize his staff in the Administrator's Office for their time and assistance in putting the presentation together. He said it was a team effort and he was proud to say the budget successfully reflected the goals and vision the board had provided.

Commissioner Zimmerman thanked Patzner for his hard work.

Commissioner Hutchinson said it had been five years of lowering taxes and reinvesting in the community. It had been one of the best experiences of his life and he wanted the public to know that they really were here to serve them. Commissioner Hutchinson said we are trying to grow our tax base so that everyone's piece of the pie was smaller.

Commissioner Reif thanked Patzner, directors, department heads and employees for their part.

Commissioner Schlessiger said the five of us could not do this without everyone else that worked for the county. We have been able to eliminate 11 positions in the last 5 years.

Commissioner Hutchinson moved to close the Budget Hearing. missioner Zimmerman seconded the motion.
