A. PROCLAMATION 2025-15: Great Bend Bat Cats Day ~ July 15, 2025:

-Commissioner Barb Esfeld will provide details. The Great Bend Bat Cats began playing in June, 2017, at Al Burns Memorial Field in Great Bend, Kansas. Managed by Roger Ward, Head Coach, the Bat Cats play from May through the end of season tournaments, with both home and away games. The Commission will be asked to adopt a Proclamation recognizing the players, staff and sponsors for their dedication to the game and their commitment to health, leadership and community.

Commissioner Esfeld said she had enjoyed having the team in Great Bend. She said they give up their summer off to come play baseball. They give up time with family and friends and brought a lot to our community. Commissioner Esfeld asked the commissioners to adopt a proclamation recognizing the players, staff and their sponsors for their dedication to the game and their commitment to help leadership in the community.

Roger Ward, Bat Cats Manager, thanked the commissioners for the honor. Ward said the early years were tough, but it had gotten easier each year. Ward said the support and the crowds had been incredible, the support from businesses and individuals had increased. Ward said he tried to teach a few life lessons along the way. Ward said this group had been his favorite one to work with. They had had trials and tribulations, kept showing up and were a great group of humans from around the country and Canada. Ward said many of them will be very successful in life. The end was always scary because you work so hard.

The players introduced themselves.

Commissioner Esfeld said her family hosted two of the players this summer. She said it had been a fun son, and she enjoyed seeing the little kids interact with the players.

Commissioner Hutchinson said the entertainment factor they brought to the community was what paid the bills and kept the organization going. He said he had been taking his own kids to play baseball for twenty years. The cherry on top was taking them to see the Bat Cats play and see the young men out in the community helping with projects. The kids see them as good players, but they also saw them volunteering in the community. Those effects were long-lasting.

Commissioner Schlessiger congratulated them on transitioning from high school sports to college sports, that was a big step. Securing a scholarship and committing to a team was a big step.

Commissioner Zimmerman said what a testament by Coach Ward to not only their athleticism but to their characters, she was very proud and wished them well.

Commissioner Reif congratulated them on a job well done and said it also took a great leader.
