**PUBLIC HEARING: Solid Waste Management Plan:** 

-Jennifer Hamby, Solid Waste Director, will present details. This Public Hearing is held for the purpose of evaluating the Solid Waste Management Plan for Barton County, Kansas.

In nifer Hamby, Solid Waste Director, said the Barton County Solid Waste Management Planning nmittee reviewed the plan every five years and recommended updates. Hamby said the plan had been reviewed and updated per KDHE regulations and was published on September 13th. Hamby said they updated the economy and major employer section, the waste tonnage, the landfill equipment section and recycling, which was where the biggest changes were made.

Commissioner Zimmerman said she was unaware until the discussion in study session that Superior Essex had zero waste. She thought that was incredible for a local employer and that was not often seen.

Commissioner Reif said it had been that way for a number of years. Hamby said they started that initiative in 2014.

-Ms. Hamby will provide details. As noted during the Public Hearing, the Barton County Solid Waste Management Plan must be reviewed and updated every five years. Should this proposed Resolution be adopted, the updated Solid Waste Management Plan would become effective in Barton County.

Jennifer Hamby, Solid Waste Director, said the Solid Waste Management Plan had been updated with the focus on recycling.

nmissioner Reif said he often was asked how long the current landfill would be used. Hamby said there was still about 90 years left for this landfill. She said that was why recycling was so important, to extend the life of the landfill. It also helped because it reduced the need to extract new materials. Hamby said that since Stutzman's had offered curbside recycling in Ellinwood as they did in Hoisington, recycling has increased significantly and continued to increase.

Commissioner Reif said he noticed that his recycling dumpster was filled quicker than his trash dumpster.

Hamby said a new company had just come to Great Bend and offered curbside recycling, so she hoped to see the increase in Great Bend as well.

Commissioner Hutchinson said he had not thought about recycling in the past as extending the life of the landfill.

Commissioner Reif said some of the easiest things to recycle were paper and cardboard. Hamby said the number one waste was food waste that a lot of it could be composted. Plastics were next and then paper and cardboard.

Commissioner Zimmerman said they did a great job on the plan, and she appreciated the updates.

Commissioner Zimmerman moved to adopt Resolution 2025-16, A Resolution Adopting the Solid Waste Management Plan for Barton County, Kansas, and Rescinding Resolution 2021-25, Same, Adopted November 30, 2021.

LEASE AGREEMENT: Linsner Property – Road and Bridge Storage:

-Chris Schartz, County Works Director, will provide details. Barton County wishes to extend the lease of approximately five acres in the NE/4, Section 16-T17S-R14S for the storage of materials and equipment used for the construction and maintenance of roadways. Leased from Kirby and Linda Linsner, it is suggested that the updated lease be extended to October 1, 2030, with an annual payment of \$850.00.

Chris Schartz, County Works Director, said the location was on NE 150 Rd, 1 and a quarter mile west of U.S. Highway 281. Schartz said they used the site for storage of materials and to park equipment.

Commissioner Reif said the agreement worked well for both parties. Schartz said the area was on a hill which was more difficult for the Linsners' to farm, the County had fenced the area and put a gate up to keep people out.

Commissioner Zimmerman said with these two leases, the pit and our location, there was a location in each of the four quadrants. Schartz said that was correct. The pit in Ellinwood was used for the southeast quadrant, the pit in Odin covered the northeast quadrant, the northwest quadrant used the Linsner lease, and the southwest quadrant used the Dyer lease.

Commissioner Esfeld moved to approve the Lease Agreement with Kirby and Linda Linsner for approximately five acres in the NE/4, Section 16-T17S-R14S. Annual cost to be paid from the Road and Bridge Fund, Right of Way Line, 002-92-6270.

Commissioner Zimmerman seconded the motion.

- A RESOLUTION ADOPTING THE SOLID WASTE MANAGEMENT PLAN FOR BARTON COUNTY, KANSAS, AND RESCINDING RESOLUTION 2021-25, SAME, ADOPTED NOVEMBER 30, 2021
- WHEREAS, the Board of County Commissioners of Barton County, Kansas, has determined the need to plan for the proper disposal of solid waste in Barton County; and
- WHEREAS, KSA 65-3405, and any amendments thereto, directs the County to establish a solid waste management committee who shall be responsible for the development of a solid waste management plan; and
- WHEREAS, on October 7, 2025, said Barton County Solid Waste Committee recommended to the Board of Barton County Commissioners the adoption of certain revisions to the Barton County Solid Waste Management Plan, said Plan having last undergone a five-year review in 2021.
- NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Barton County, Kansas, that by adoption of this Resolution, the Solid Waste Management Plan, incorporated herein by reference, is hereby endorsed for public use in Barton County, Kansas; and
- FURTHER, that said plan was reviewed prior to adoption in a Public Hearing held on October 7, 2025, in accordance with KAR 28-29-78; and
- FURTHER, that said plan will be submitted to the Kansas Department of Health and Environment for approval; and
- FURTHER, that Resolution 2021-25, Same, adopted November 30, 2021, and the Solid Waste Management Plan adopted thereunder, shall be rescinded upon approval of the updated plan by the Kansas Department of Health and Environment.
- FURTHER, that the Solid Waste Director is hereby directed to have the most current version of the plan available for the public.
