I. OPENING BUSINESS:

Commissioner Reif called the meeting to order at 9:00 A.M.

Commissioner Hutchinson moved to approve the agenda.

Commissioner Zimmerman seconded the motion.

All voted aye. Motion passed.

Commissioner Schlessiger moved to approve the minutes of the June 16, 2026, and the June 23, 2026, Regular Meetings.

Commissioner Esfeld seconded the motion.

III. APPROVAL OF APPROPRIATIONS:

-Bev Schmeidler, County Clerk, will present details. An Accounts Payable Register will be submitted to the Commission for the period of June 16, 2026, and ending June 30, 2026.

Bev Schmeidler, County Clerk, presented details and asked for approval.

Commissioner Esfeld moved to approve appropriations for the period of June 16, 2026, to June 30, 2026.

Authorize the Chairman to sign on behalf of the Commission.

Commissioner Schlessiger seconded the motion.

IV. NEW BUSINESS:

A. CITY OF ELLINWOOD: Cooperative Effort to Seal a City Street:

-Chris Scharzt, County Works Director, will provide details. The City of Ellinwood has requested assistance with sealing of a certain road, specifically Park Street from US 56 to 7th Street. As an independent contractor, the County would receive no more than an estimated \$12,500.00 for labor and equipment.

Chris Scharzt, County Works Director, presented details and said depending on when they could actually seal the road, they should be under \$12,500.00. Scharzt said they had done this for the City of Claflin in the past as well. Scharzt said they were working in the southeast quadrant this year and would be going through Ellinwood so it would be easy to do. They would be sealing part of 7th Street as one of the County blacktops.

Commissioner Reif said they had a good working relationship with the cities. Schartz said they did have good relationships with the cities and things like this helped keep that going.

Commissioner Schlessiger said she appreciated that they could help the City of Ellinwood.

Commissioner Reif said you charge FEMA rates, correct. Schartz said that was correct, they always charge FEMA rates when doing work for the cities.

Commissioner Zimmerman moved to authorize the Road and Bridge Department to assist the City of Ellinwood in sealing Park Street from US 56 to 7th Street under a signed agreement estimated at \$12,500.00 for labor and equipment. Direct the Commission Chairman to sign the agreement on behalf of the County.

Commissioner Schlessiger seconded the motion.

All voted aye. Motion passed.

B. COUNTY WORKS: Bulk Diesel Fuel Bids for 2026 – 2027:

-Mr. Schartz will provide details. On June 22, 2026, the Road and Bridge Department contacted local vendors to determine bulk fuel pricing. The request included the period of July 1, 2026, through June 30, 2027, or the 50,000-gallon mark is exceeded. After review, Mr. Schartz was given the discretion to approve a price that was beneficial to the County. On June 24, 2026, Mr. Schartz contacted American Plains CO-OP and accepted an updated quote of \$3.29 per gallon for clear diesel and \$3.08 per gallon for dyed diesel.

Chris Schartz, County Works Director, said he got bids from American Plains CO-OP on June 22nd for \$3.35 per gallon for clear diesel and \$3.14 per gallon for dyed diesel. Schartz said when he went back on June 24th, the prices were slightly lower, and he locked in those prices. He said Zip's Service would like to bid but they do not have the capability of taking a bobtail to the dredge at the pit by Ellinwood.

Commissioner Schlessiger said with the volatility of the current fuel market, this was a good price. Schartz said yes, it had even gone up since he got the quote.

Commissioner Schlessiger asked what pump price was currently. Schartz said about \$4.50 per gallon for clear so this was a considerable savings.

Commissioner Esfeld asked Schartz how long 50,000 gallons would last. Schartz said that varied depending on where in the county they were working. Last year, they were in the southwest quadrant, close to town, so that got them to right at a year. He said next year they would be in the northeast quadrant so it may be a month or two short of the year. Schartz said it also depended on how much snow we get in the winter.

Commissioner Hutchinson moved to ratify the \$3.29 price per gallon for clear diesel and \$3.08 per gallon for dyed diesel from American Plains CO-OP from July 1, 2026, to June 30, 2027, or up to 50,000 gallons of diesel fuel whichever comes first. Cost to be paid from the Road and Bridge Fund, Vehicle Fuel Line, 002-92-5175.

Commissioner Esfeld seconded the motion.

All voted aye. Motion passed.

C. SOLID WASTE: Bulk Diesel Fuel Bids for 2026 – 2027:

-Jennifer Hamby, Solid Waste Director, has also been hesitant to lock in a price for bulk diesel. After discussion with Mr. Schartz, she contacted the two local vendors that can accommodate Solid Waste's

ds for bulk diesel. Bids will be presented at this time for diesel through June 30, 2027, or the 25,000-gallon mark is exceeded.

Jennifer Hamby, Solid Waste Director, said the Landfill also goes out for fuel bids annually. She received two bids on June 24th. Hamby said the bid from United Ag Service was for \$3.35 per gallon with American Plains CO-OP bidding \$3.41 per gallon. Hamby said the bids were for 25,000 gallons or until June 30, 2027, whichever came first. She held off as long as she could, watching the markets.

Commissioner Reif asked Hamby if they were able to take a full semi load. Hamby said they deliver bobtails weekly to them.

Commissioner Reif said that was always a little bit more. Hamby said yes, it was for delivery. She would like to go with the lower bid from United Ag which they currently used.

Commissioner Reif asked Hamby if they were still local. Hamby said yes, they had locations in Galatia, Hoisington and Olmitz.

Commissioner Schlessiger moved to approve the \$3.355, I guess there is an extra 5, is that right, price per gallon from United Ag Service for one year or up to 25,000 gallons of diesel fuel. Cost to be paid from the Solid Waste Fund, Heavy Equipment Fuel Line, 140-65-5415. Is that a typo. It is just \$3.35.

Commissioner Zimmerman said no.

Hamby said that was how they put it on there, 355.

Commissioner Zimmerman said the code.

Commissioner Reif said yeah, the code.

Commissioner Zimmerman said could you repeat the code.

Hamby said oh, sorry. Oh, I am sorry. Down there.

Commissioner Reif said the equipment fuel line.

Commissioner Schlessiger said 140-65-5415.

Commissioner Hutchinson said you did it again.
